1. Answer **any one** of the following questions (750 words):

- a) Discuss Lukacs' s views about the modernist obsession with the 'psychopathological' in literature. Do you agree with his view? Give reasons for your answer with suitable references from literary texts. (7+2+6)
- b) Critically analyze how Wolfgang Iser defines the text, work, and the reader and theorizes the notion of "interaction."
- c) Would you say Roland Barthes's essay 'The Death of the Author' completely reverses the ideas of traditional authorship and traditional readership? Substantiate with close reference to the text.
- 2. Answer **any one** of the following questions (250 words):

- a) How, according to Lukacs, does individual solitariness in modernist literature differ from that found in the literature of traditional realism?
- b) Write a short note on "blanks" and "ideation" as conceptualized by Iser.
- c) Write briefly on the idea of the scriptor as found in Roland Barthes's 'The Death of the Author'.

- a) Would you consider Derrida's notion of the supplement as adequate in addressing the problematic of totalization in language? Answer with suitable references to the essay "Structure, Sign and Play in the Discourse of the Human Sciences".
- b) Show how the binary of self and other contributes to the formation of the 'visual pleasure' of the mainstream cinema as discussed in Laura Mulvey's essay 'Visual Pleasure and Narrative Cinema'.
- c) What, according to Baudrillard, are the characteristics of a simulacrum? Answer with reference to any three examples.
- 4. Answer **any one** of the following questions (250 words):

- a) What, according to Derrida, makes the engineer a species of the bricoleur?
- b) What, according to Laura Mulvey, are the differences between narrative and spectacles? Discuss briefly.
- c) Write a short note on the four phases of the image as theorized by Baudrillard.
